Open Letter to the Justices of the Supreme Court of the United States of America

Would this Court knowingly deny a Petition for a Writ of Certiorari involving serious intentional constitutional violations by a state judiciary against the rule of law, the Due Process and Equal Protection Clauses of the 14th Amendment, the First Amendment Free Speech Clause, and separation of powers? Violations resulting in grave and permanent harm to a petitioner and harm to the public? (See attachment A.)

Such petition was supposedly denied by this court last November. However, I suspect something untoward\* happened which prevented this court from getting or properly considering my petition. Because I cannot conceive that this court would knowingly deny it and allow the New Jersey government to trample on the Constitution and the rule of law and tyrannize its citizens at will. Thus, I kindly ask this court to consider and grant it at this time.

I realize that this court doesn't usually intervene in state cases. And under normal circumstances, it would not be necessary. States DO have judiciaries to defend the constitutional rights of their citizens. But unfortunately, that is NOT how it works in NJ, as my petition shows. In NJ judges ignore the law, repeatedly deny due process, twist facts, outright lie about facts, and

defame petitioners' character in order to support an agency's denial of their disability pension. And they seal their appeal records against the law to cover up their wrongdoings. All this happened in my case with the blessing of the NJ Supreme Court, who refused to review my case twice.

As noted on p.2 of my petition, these grave violations of the Constitution by the NJ Judiciary to deny rightful claimants their disability pensions have occurred in NJ since at least 1980, when NJ Supreme Court Justice Pashman had the integrity to denounce what he perceived as collusion between the court he was part of and state agencies.

And because of the denial of my Petition for a Writ of Certiorari, unless this court intervenes at this time, the NJ government will have the green light to continue to set aside the Constitution and all sense of justice whenever it chooses to do so in order to harm any citizen or group of citizens it wants to harm, just as it did to me.

I realize that most people will have a very hard time believing that so many presumably honorable people would engage in dishonest and, even, criminal behavior. And I realize that most people will believe them much more trustworthy than a single petitioner, especially when said petitioner has seemingly more to gain by lying. We all have heard about those cases involving dishonest claimants. But we don't hear about the cases unjustly denied. Perhaps because the NJ media does not seem inclined to expose government corruption, as suggested by the fact that they ignored my requests to investigate and expose this case.

One can find out the veracity of my claims by carefully reading my petition, which the NJ government failed to respond to.

I came to the US from Spain as a young woman long ago and have since worked and studied hard. I got two master's degrees and had been working for years as a Spanish teacher at an elementary school before I became disabled after suffering a Brain Injury. I am not claiming to be a saint, but I do have a record of work ethic and of being a law-abiding and responsible citizen.

And I may be foreign-born and speak with a heavy Spanish accent, but I have more of an American Spirit in me than all these government officials put together. Because they have shown by their actions to be on the wrong side of truth, liberty, and justice.

I am now 56 years old and have been fighting for the rightful disability pension I need to live for 11 long years against these so-called honorable people who are hell-bent on denying my pension against the law and all sense of justice. And I have been fighting as a pro se litigant after realizing that the Trenton attorney I originally hired for my appeal was likely in cahoots with the state agency, since he did many things extremely damaging to my case.

All these years I could not rest my brain, as I had to devote all my time and energy to learn about the law and to write my briefs and motions. I came close to giving up many times, and every time that happened, I prayed to my Lord and Savior Jesus Christ for strength to continue fighting. And He gave me the strength that I needed.

But after the NJ Supreme Court denied my requests for an investigation of a likely collusion between the Appellate Court and the state agency while my appeal was ongoing and later denied my requests for review, my only hope for due process was this court.

I refuse to believe that there weren't even FOUR justices who felt it necessary to grant my petition given the 11-year denial of due process by the NJ courts, the rest of their very serious intentional constitutional violations, the grave and permanent harm done to me, and the dreadful impact that not granting this petition will have on New Jerseyans for years to come and on the nation, as it will set a terrible precedent for all state governments to oppress their citizens at will.

Thus, I have reason to believe that this court was somehow prevented from getting or properly considering my petition, And I ask this court to consider and grant it now to give a solution to the very serious and permanent problems the deliberate Constitutional violations by the NJ government have caused me. After an 11-year appeal process, this court is my last resort.

I hold this profession in high esteem and I believe there are many honorable judges (Justice Thomas being one of them. \*) But there are also MANY who break their oath of office and pervert justice, as my case shows. And I realize this court cannot just wave its magic wand and automatically right all wrongs committed throughout the country. But it can and should grant petitions such as this where a state government has so brazenly defied the Constitution and the rule of law, gravely harmed a citizen and denied the public its right to inspect a public record.
